Sub: Phase-wise release of MLALAD and CM-SA fund for the year 2026-27 and onwards

Madam/Sir,

In inviting a reference to the subject cited above, I am directed to say that Government after careful consideration has decided to release/ sanction the MLALADS and CM-Special Assistance Fund for the year 2026-27 and onwards, in phased manner (03 phases) stipulating the following conditions:

Sl. No.	Instalment Phase	Expenditure & UC (Utilization Certificate) Submission Details	Funds to be Released in the Current Financial Year
1	First Phase	Submission of 70% UCs (Exp.) against the funds allotted/sanctioned for the previous financial year	40%
2	Second Phase	Submission of UCs for at least 20% out of the remaining 30% funds allotted/sanctioned in the previous financial year	30%
3	Third Phase	Submission of UCs for at least 40% out of the 70% funds released in the current financial year	30%

To ensure the efficient and timely utilization of unutilized funds lying with Zilla parishads/Executive Agencies, and to maintain financial discipline, transparency, and accountability, Zilla parishads/ Executive agencies **shall not earmark or block** the available MLALAD/CM-SA funds for any specific year or any specific approved project. Instead, the available funds can be utilized for any approved MLALAD/CM-SA project of any year. This will prevent funds from lying idle in projects where expenditure is delayed or not taking place.
